## Friends of Istokpoga Annual Meeting Held

The annual meeting of the Friends of Istokpoga Lake Association, Inc. was held at the Lorida Community Center in Lorida, Florida, on February 24, 2005.

Dr. Paul Gray, Florida Audubon Society, presented "The Birds of Istokpoga". It was an awesome presentation and we sincerely thank Dr. Gray for this illuminating look at our birds.

Karen Whall, a biologist with the Florida Fish and Wildlife Conservation Commission, presented an update to the bass tracking she gave us last year. If you weren't there you really missed another good presentation.

We also held our annual election of Directors. Bill Dwinell announced he was no longer going to be president and that he was willing to remain on the Board of Directors for another year if someone else was willing to be President.

Nominations were made and by unanimous vote Gary Albin, Bill Dwinell, Bert Galloway, Don Linton, Jeannette Porter, Jack Richie, and Jim Wilburn were elected to the Board of Directors (BOD).

In a subsequent meeting the BOD elected Bert Galloway President, Don

Linton Vice-president, and Jeannie Porter as Secretary / Treasurer.

## Hydrilla Treatment

The Department of Environmental Protection (DEP) started the lake treatment for hydrilla in February. This treatment was planned to have several applications of liquid form of Sonar.

After the initial application, the concentration of the herbicide several reports of damage to plants other than hydrilla

were received. One report stated that crop damage south of the S-68 structure was expected to occur because of the anticipated high levels of Sonar in the canal. DEP applied powdered charcoal in the canal to absorb the sonar and stop any potential damage.

The treatments have stopped for this year and are not expected to resume.

So far we have not heard any new plan from DEP to address the continuing problem of hydrilla in our lake.

# Lake Istokpoga Needs Your Help

Concerned members of Friends of Istokpoga take heed about the following predictions in regard to Lake Okeechobee's declining health.

Lake Okeechobee was in trouble before last years hurricanes churned up a thick layer of pollution that had settled on its bottom and turned the water the color of day old coffee.

The mess not only threatens the lake's diverse fish and plant populations but also jeopardizes the water supplies and economies of nearby communities and an environmental project of greater concern. (The \$8.4 billion Everglades Restoration).

Paul Gray, the science coordinator for Audubon's Lake Okeechobee program describes recent visits to the lake as more and more demoralizing.

We don't know how bad it's going to get before it starts getting better," he said.

At the Pahokee marina, a pier normally full of fishermen has been deserted for months. The few dozen boats that one would normally see have all but disappeared

"What you're going to find this summer is this lake is going to turn just as green and just as slimy as anything you've seen in a science fiction movie," said the Pahokee's Mayor. "When that starts, no one will get on that water".

The unsavory green color comes from toxic algae, which blooms from the pollutions spreading through the lake and smothers plants and fish. The coming

algae bloom is drawing alarming comparisons to an ecological disaster at central Florida's Lake Apopka which succumbed to similar problems in the 1940s.

As you can see from the proceeding account, Lake Okeechobee has a big problem and the answers to fix are costly.

Our reason for including this in our newsletter is to alert you to the fact that Istokpoga could end up in the same condition as Okeechobee or Apopka.

We need action taken in the near future to stop the large levels of phosphorus, the prime pollutant, that are entering Lake Istokpoga from numerous sources. Istokpoga's phosphorus is already high and if we do nothing it will become another Okeechobee or Lake Apopka in the very near future.

We need you as concerned citizens to contact our elected officials in regard to this problem by letter, phone or visitation to let them know about our concerns. The health of Lake Istokpoga is dependent on us solving this problem.
